

talks begin in China

BEIJING: Top Thai and Cambodian diplomats began China-mediated talks on Sunday, a day after signing a ceasefire to halt weeks of deadly border fighting that killed over 100 people and displaced more than 500,000. China, joined by the US and Malaysia, is seeking to ensure the truce holds and promote lasting peace, with trilateral talks planned on Monday.
